Section 1 Operation

1. DIAGNOSTIC OPERATION

The Micro Technology, Inc: (MTI) RLO2 diagnostic (RLO2DG) is a stand alone memory resident program, which can be bootstrapped or run from any device supported by Digital Equipment Corporation (DEC*) RT-11 version 4 operating system.

1.1. PROTECTING DISTRIBUTED DIAGNOSTIC

RLO2DG diagnostic is supplied on either the Winchester drive, unit zero, or the RXO2 compatible Floppy Diskette. The medium provided is dependent upon system options purchased. Either source will have the diagnostic program recorded with DEC's RT-11 file structure.

Backup can be accomplished using the COPY Command of RT-11. A bootable version can be generated on any storage device supported by RT-11 version 4.

Example commands to build device bootable backup:

- 1. COPY/SYS DD:RLO2DG.SYS YY:FILENAME
- 2. COPY/SYS SY:YY.SYS YY:
- 3. COPY/BOOT YY:FILENAME YY:

where DD = Source device (DY or DL)

- YY = Target device
- SY = System device

Only step one (1) is required for archival backup or where the RT11 RUN command is used for program activation (See Section 1.2).

*DEC is a registered trademark of Digital Equipment Corporation.

1.2. STARTING THE DIAGNOSTIC

The distributed RLO2DG program is bootable from the media provided. The RT-11 RUN or GET command can be used if device containing the diagnostic program isn't bootable. When using this method the program start/restart address is at location 6100.

If the diagnostic was provided only on the Winchester then it is imperative that the program be copied from the unit (Drive O) to non volatile media (See Section 1.1).

CAUTION

Running the RLO2DG diagnostic program may cause loss of recorded Winchester stored program.

1.3. INITIALIZATION

Starting the RLO2DG program by bootstrap or via RT-11 RUN/GET commands yields the following program identification:

For list of options type 'HE (CR)'

The program begins a dialogue requiring operator responses. Queries requiring numeric input are expected to be in octal; exceptions are noted. Affirmative or negative responses are indicated by default prompts Y for yes and N for no.

Input is terminated by carriage return (CR). Typing only a carriage return signals the program that the default value is to be used. Note the default response is displayed adjacent to the prompt. The following queries are presented as a part of the program startup and initialization.

Unibus device? N

Special processing is required for UNIBUS type controllers.

of controllers? 1

Enter the number of MLV11/MLV11M controllers present. A maximum of two (2) controllers are supported. The next set of questions are duplicated for each controller present.

First controller address? 174400

Enter the address to which the controller is configured. All device register accesses are made relative to this address.

_Vector address? 160

Address to which the controller has been strapped for interrupt.

Priority? 5

Priority level at which the controller will interrupt. Do not confuse this with interrupt service level.

- # of units? 4

Enter the total number of RLO2's emulated by the Winchester drive(s) attached to the controller in question.

Type of controller - MLV11 (8")? N

Respond affirmatively if the controller type is MLV11; else type a carriage return. The operator will be prompted for the next type until a yes response is entered.

Controller 174400 Unit #0 present? N

The unit present query is alternately presented with the use unit query, that follows, until the number of units input via a previous prompt is selected. The program is intolerant of errors. Should an error be detected it is suggested that the operator type Control C (^C). This control action will return the keyboard to a listening mode. The Hardware directive HW can be used to reconfigure the system (See Section 1.4).

This query is presented for each affirmative response to the Unit Present query above.

At this point the system configuration has been completely described. An attempt is made to read the Defective Map File. The following dialogue will appear only if the Winchester drive(s) described above is not formatted (See Section 4).

Map file doesn't exist, Drive hasn't been formatted, Original index time? 2048

Original index time is entered as a decimal integer. The number represents 1/100 of a millisecond.

Write pattern ? 4

Enter pattern number to be used by test program (See Section 2.0 and Appendix A.).

Type 'Y' to select a test, Type '^C' to exit to keyboard monitor, Type anything else to perform tests 1-13.

At this point the operator must decide whether or not to run all tests, selected test, or perform utility functions. It is important to note tests 14 and 15 can only be activated by entering 'Y' to this query.

Enter test number or request MENU (M)

A yes response to the previous query initiates the above. There is no default for this query and the input is either numeric or 'M' is the response:

1.4. OPERATOR DIRECTIVES

Control C is valid operator input at any point within the RLO2DG program. Entering [°]C terminates whatever operation is being performed. The program then enters a keyboard listening mode. This mode is indicated by the keyboard monitor asterisk (*); the following operator directives are valid input when it appears:

SELECT ALL TESTS Initializes the diagnostic jump table to include all test addresses. This command is normally used to reset selected tests following the ST command.

- SELECT DEFECTIVE BYTE MAPPING A subset of the Operator Directives is enabled. These commands allow the operator to correct, define, display, format, locate and initialize the defective byte table and/or locations on the selected unit. (See Section 4.0).
- INITIALIZE DISK WITH PATTERN Allows the operator to write selectable units with selectable pattern.

FORMAT DISK All units or selectable surfaces can be formatted.

PRINT THIS LIST List all the operator directives.

Starts the first test program in jump table.

- ST n,n,n,... SEQUENCE TEST This directive allows an operator to schedule the order and number of tests to be included in diagnostic jump table.
- TM TYPE TEST MENU List number and brief description of the tests that make up the diagnostic program.
- TP SELECT TEST WRITE PATTERN Allows operator to select the pattern to be used by test programs. (See Section 2.10 Test 12).

1.5. EXAMPLES OF DIRECTIVE RESPONSE

In the examples that follow, operator input is indicated by underscore. Directive commands consist of two (2) character mnemonics followed optionally by a space and numeric data separated by commas. All input must be terminated with a carriage return. Spaces are not permitted except for the initial space separating command from optional data.

Two (2) prompts are used by the program to indicate that the keyboard monitor is awaiting input. The first prompt, an asterisk (*), is used by the Executive monitor. Optional input to the asterisk prompt must be in octal. The second prompt BM>, is presented by the Defect Mapping monitor. Optional command inputs are expected to be decimal integer values.

*<u>OP</u> INV CMD! For list of options type 'HE cr'

An invalid command causes this response. The keyboard monitors are unforgiving. Should the operator mistype a command, pressing a delete key will not correct the error.

1.5.1. *AT

There is no response, except the keyboard moditor returns with an asterisk. A prompt is returned at the completion of all directive commands. The test program jump table is initialized with addresses of Tests 1-13 (See Section 2).

1.5.2. *****BM

This command switches the operator responses to the Defect Mapping utility.

Is event clock disabled? N Y

This dialogue is conditional. It only appears if an event clock is present and was enabled at program startup. Note that no prompt is present. The prompt is not presented until the directive function is complete.

Attempting to compute index time

The above dialogue is presented to inform the operator of the delay. The program is determining the current index time (See Section 4).

Current index time? 2049 2048

Current index time calculated by the program is displayed for operator approval. Although the example shows operator input the normal response should be a carriage return.

Original index time? 2048 2044

The default value displayed is read from the defect map file, which is generated via the formatting process (See Section 4). As in the previous example the normal response is a carriage return.

The new prompt BM is displayed, indicating that input is now being directed to the Defect Mapping utility. Only commands listed in the above help file are acceptable. Optional input is expected to be decimal integers. See Section 4 for complete description of formatting and defect mapping.

Permanent defects are entered into the Defect Map File. Entries aren't made permanent until the track has been formatted and the defect map is updated on the drive. - BM>DS 234,1,34

DT allows the operator to view the current entries within the Defect Map File. Entries that have been previously mapped are delineated with an asterisk adjacent to the entry number. Entries flagged with an asterisk can not be edited.

Edit directives CB and CS are used to correct input errors without altering the table's order. Again only unmapped entries can be altered (those without an asterisk).

Directives DE n, ZE or RD are used to delete one or all preformated entries. There are currently no differences between directives ZE and RD in Version 4 RLO2DG. In both cases the permanent disk file is read to replace current memory copy.

The directives LB and LT prove to very important tools for the operator. DEC's RT-11 provides bad block locations when using the DIRECTORY/BAD command. The locations provided by RT-11 can be used with the LB directive to locate the defective sector. RLO2DG calculates the logical sector pair that make up the logical block. Forty (40) reads of 128 words are performed on each sector. If any errors are detected, the physical location and errors detected are displayed. This information can be used via the DS command to defect map the failing sector. Directive LT provides the information for logical track and sector input, the location format provided by the RLO2DG Diagnostic program.

The format track directive initiates the defect mapping process. Each entry of the defect map is examined for mapping candidates (those entries without an asterisk). The physical location is calculated and defect mapped; this is repeated for each unmapped entry. An updated defect map is written to each unit (See Section 4).

To perform formatting ECC must be disabled.

Total and partial formatting are initiated with the directive FM. The initial dialogue is the same as BM; that is, if the clock wasn't disabled at startup the first query will appear, etc. This example is for total formatting. Since total formatting destroys the Bad Sector File a serial number input is requested. In this example formatting was not accomplished because the ECC jumper wasn't disabled (See Section 4).

Tests are run via a jump table. There are twelve (12) entries, one for each possible test. The table is initialized at startup and following the execution of operator directives HW, AT, ST and IP (See Sections 1.4 and 1.5).

2.1. TEST 1

Verifies that the MLV11/MLV11M responds to register access. The Control and Status, Bus, Disk and Multipurpose registers are addressed. Program traps are fielded to determine failing registers.

2.2. TEST 2

A varying pattern is loaded and set into the Bus and Disk Address registers. After each set and load the registers are read and compared with the current pattern. Failing register and the values expected and received are displayed.

2.3. TEST 3

Tests the ability to set, load and read the Control and Status register. Every combination of drive, interrupt and function is used. The register is checked following each load and set operation to verify it remains unchanged. The Bus and Disk registers are also loaded and read to insure their values remain unchanged.

2.4. TEST 4

Tests the ability of the controller to effect an interrupt following an operation complete. Functions are initiated at device priority to verify its ability to interrupt at that level.

2.5. TEST 5

Tests that every cylinder can be addressed. The heads are stepped in contracting and growing pattern around the center cylinder. Four passes through the disk are made.

2.6. TEST 6

Tests the controller response to invalid sector addresses. Attempts are made to write sector 40 and beyond. Unexpected responses are reported.

2.7. TEST 7

Tests the ability to seek to a given track. Similar to Test 5; however, this test uses random seeks on random units followed by read header to verify positioning.

2.8. TEST 10

Tests the ability to read disk data. Random units, tracks, sector, and number of words to read are calculated. The data are read and compared using the write check function.

CAUTION

The following tests perform write functions; recorded data on selected units will be destroyed.

2.9. TEST 11

Tests the recovery of data without header check. A random unit and location are selected. Read header is executed until preceding sector is reached; read without header check is used to capture data. The data read are compared with the pattern written.

2.10. TEST 12

Tests the write function. Random units and locations are written with the preselected data pattern (selected at startup or with TP directive). Data verification is performed by comparing the data read and written.

2.11. TEST 13

Same as Test 12 except for data pattern and method of comparison. Prior to each write a randomly selected pattern is written to the output buffer. Following the write function, the written data are read and compared to the data pattern written.

2.12. TEST 14

Randomly selects Test 7 through 13 to be executed. Selected test performed for one iteration. In effect, the tests are operated as subroutines.

2.13. TEST 15

Tests each sector of the designated unit (selected at the start of the test) to check for sector read errors.

Section 3 Error Messages

3. GENERAL

Error printouts are composed of four lines. Line one contains the error description, line two the data headers, line three the data and line four the disk address.

The majority of error processing is performed within the common test interrupt handler; therefore, all errors can't be associated with a unique test. Where possible these associations have been shown.

3.1. BUS ADDR REG. ERROR

Test 2 displays this error when the value in the Bus Address register changes without a control function being initiated. The values expected and received are displayed.

3.2. CANNOT ADDRESS XXXX

Test 1 displays this error when unable to address the register in question, where xxxx is the register mnemonic RLCS, RLBA, RLDA or RLMP. Lines 2, 3 and 4 are not displayed.

3.3. CONTROLLER ERROR

Test 4 initiated a controller function with interrupt enabled. The interrupt wasn't accompanied by controller ready. The value of the Control and Status register is displayed.

3.4. DATA COMPARISON ERROR

Tests 10, 11 and 13 cause this error to be displayed. The common routine used by the tests discovered a mismatch between the input/output buffer and the pattern used to create it. Expected and received values are displayed.

3.5. DATA CRC

Tests 10, 11 and 13 display this error which indicates that while reading a data field from the disk, an error was detected. The device registers are displayed.

Test 11 displays this error indicating that the FIFO RAM was more than half full and the controller was unable to read the next sector.

3.7. DISK ADDR REG. ERROR

Test 2 loaded or set a value into the RLDA which changed without a controller function being initiated. Expected and received values are displayed.

3.9. HEADER CRC

Tests 5, 7-15 display this error, indicating the controller was unable to read a header from disk (the header CRC was invalid). Device registers are displayed.

3.10. HEADER NOT FOUND

Tests 10, 12 and 13 produce this error indicating that OPI timeout occurred while the controller was in search of a correct sector to read or write. A header compare did not occur. Device registers are displayed.

3.11. NON-EXISTENT MEMORY

Tests 10-13 generate this error indicating that the memory location addressed did not respond within the bus timeout period. The device registers are displayed.

3.12. OPI ERROR

Tests 5-13 display this error when a controller operation does not complete within the OPI timeout period. Controller registers are displayed.

Section 4 Formatting

4. GENERAL

The purpose of formatting is to section the disk tracks into smaller addressable units called sectors. The Winchester drives used with the MLV11/MLV11M controllers are soft sectored type, meaning that the beginning of each sector is defined by a pre-written identification (ID) field which contains the sector address plus cylinder and head information. The ID field is then followed by a user data field.

The formatting scheme used by the MLV11/MLV11M controller permits the recovery of areas containing manufacturing defects.

The MLV11/MLV11M controller provides full formatting capability, which writes both sector headers and data fields across all tracks of a selected surface. In addition a media defect mapping algorithm is available to correct for media defects on a track-by-track basis.

. NOTE

1

If formatting or defect mapping is requested during testing, the HW function should be invoked before testing is resumed. Failure to do this may result in tracking errors during testing. When a track is formatted a "blind" spare section is written following the last sector on the track. Mapping a defect causes the specified track to be formatted. All sectors prior to the sector containing the defect are written as normal. Next the sector area containing the defect is written as a gap. Following this gap and beginning with the sector skipped, the sectors are written as normal, absorbing the "blind" spare sector at the end of the track. The advantage of this method is that it does not affect drive performance as with alternate track schemes provided by other controllers, in particular, the sector replacement technique. This technique is supported by the RLO2DG Diagnostic; however, no tools are provided for updating DEC's Bad Sector Map Files.

The RLO2DG Diagnostic program does maintain a Defect Map File. This file is created when a unit is formatted initially. The program will attempt to read this file at startup. If the Defect Map File does not exist on any of the units within a drive then the drive is considered unformatted.

Information contained within the Defect Map File is:

Word 0 - Table identification

- 1 Original (factory) index time.
- 2 File Status.
- 3 Number of entries
- 4 Cylinder number
- 5 Head number (surface).
- 6 Sector number.
- 7 Byte number.
- n Checksum word.

Defect information is provided by the drive manufacturer, notably:

Original Index Time Rotation time at which prerecorded data were initialized for each defect detected.

Cylinder The cylinder address that contains the defect.

Head - surface The physical surface number

Byte Address Offset from index point.

Two type of entries are maintained in the Defect Map File, permanent and non permanent. Permanent entries are those defects entered with byte offset (manufacturer supplied locations). Non permanent entries are those locations entered relative to disk format (location identified by sector). The Winchester drive supplied by Micro Technology, Inc. has been completely formatted. DEC's Bad Block Replacement Table is initialized with the drive serial number and zero bad sectors. MTI's Defect Map File has been initialized with the locations provided by the disk manufacturer and the disk has been defect mapped.

MTI's Defect Map File is maintained in duplicate at sectors 19 and 39, cylinder 511, bottom surface, of each unit within a disk drive.

NOTE

Prior to attempting a format, the jumper disabling ECC must be inserted (See Controller Manual). If the system configuration consists of two (2) drives per controller, the physical drive to be formatted or defect mapped must be specified in response to a query.

The FM directive will initiate dialogue with the formatting program. Prompts will guide the operation for the necessary responses. When an operator reformats a unit the Defect Map File is used. Permanent entries referencing the unit and surface being reformatted are defect mapped. Non-permanent entries referencing the selected surface will be deleted. When formatting/reformatting is complete the Defect Map File is updated on all units of the drive. Defect mapping is automatically performed following any format operation.

4.1. FORMATTING UTILITY

The formatting utility is capable of effecting both surface and defect formatting. The two directives used to initiate formatting are FM for surface, and BM for defect mapping.

In the following paragraphs are detailed examples of total device, unit, surface formatting and defect mapping. The drive type used in the example contains three (3) logical units.

4.2. TOTAL FORMATTING

Before starting any formatting operation the steps noted in Section 4.0 must be performed and the ECC disabled.

NOTE

If a total format is requested only those units specified as present and in use will be formatted.

.

In this and subsequent examples, operator input is indicated by underscore and terminated by carriage return (not shown).

After serial number is entered, the formatting process is performed on both surfaces of the first logical unit. The Bad Sector Map Files required by DEC are created, containing the serial number entered and zero bad sector entries. The serial number is incremented and the process repeated until all units have been formatted. Nonpermanent entries of the Defect Map File are removed.

Remapping defective locations . . .

The program maps each of the remaining locations contained in the Defect Map File and then rewrites it to each unit. This completes the total format process.

NOTE

Do not forget to enable the ECC controller function; damage to recorded data could be experienced if formatting remains enabled.

4.3. DEFECT MAPPING

The following information was supplied by the disk manufacturer for the drive used in our examples:

The command FT initiates the actual mapping process. The physical location of each Defect Map File entry is calculated and the sectors containing the defects are mapped out.

Unit formatting is accomplished by initiating the directive FM for each surface of the logical unit.

Remapping defective locations . . .

After a surface is formatted the Bad Sector File is optionally created. Optionally because the file exists only on the bottom logical surface. The Defect Map File is updated, nonpermanent entries associated with surface and unit selected are removed, permanent entries are defect mapped, and the updated file is rewritten to each unit of the drive.

4.5. MAPPING A BAD SECTOR

Bad sectors detected by the diagnostic, an operating system or user programs can be defect mapped. The defect mapping function provides two methods of locating potentially bad disk areas. Directives for initiating these functions are LB for locating defective sectors within a logical block and LT for the logical track and sector.
